RECOMMENDATION

1. It is recommended that Cabinet approve:
 - (a) the Military History Heritage Sites and Trails Programme at Attachment A, noting the programme total of \$976,000 in 91/92, \$180,000 in 92/93 and \$40,000 in 93/94; and noting that by substitution within existing programmes, additional funding of \$350,000 only would be sought in 91/92
 - (b) use of NT appropriation of \$80,000 in 1991/92 in anticipation of Commonwealth approval and reimbursement through the National Estate Grants programme, and
 - (c) Capital Works Programme substitution of \$400,000 on the Transport and Works Capital Works Programme.

BACKGROUND

2. In November 1990, the Chief Minister announced the establishment of a Central Planning Committee to prepare the Territory for the 1992 WWII 50th commemorative year activities. The Committee established a number of sub-committees, including a Military History Heritage Sub-Committee.

3. The Military History Heritage Sub-Committee, comprising officers from the Department of the Chief Minister, Museums and Art Galleries, Conservation Commission and NT Tourist Commission, together with the Department of Transport and Works, has developed a programme for military history displays, interpretation, heritage sites and trails. The recommended draft programme is at Attachment A.
4. The remaining concrete slabs, slit trenches, munition stores, revetments and gun emplacements scattered around old airstrips, main centres and main roads in the Territory as indicated at Attachment A are selections of the last relics of the only war fought on Australian soil and are an untapped source of interest and information that can enhance the Territory's tourist industry.

CONSIDERATION OF THE ISSUES

5. Primary sites containing visible relics of WWII activity are at or near Alice Springs, Barrow Creek, Banka Banka, Churchill Head, Daly Waters, Larrimah, Gorrie Airfield, Mataranka, Katherine, Manbulloo, McDonald Airfield, Fenton Airfield, Brock's Creek, Adelaide River/Snake Creek, Glenluckie Creek, Batchelor, Livingstone Airfield, Hughes Airfield, Strauss Airfield, East Arm, Frances Bay, Parap, East Point, Lee Point/Casuarina Beach, Darwin Airport, Darwin City and Gove.

6. Most sites are within 7km of the Stuart Highway and are accessible by conventional drive vehicle for 99% of the year enabling easy access by interested visitors. Minimal roadworks will be required to maintain easy access. Highway directional signage will need to be considered by Transport and Works, along with egress to and from the Highway.
7. Major sites and most minor sites have been documented by wartime historians and conservation architects for the National Trust or the Museum and Art Galleries Board through grants provided by the National Estate Grants Programme and the Northern Territory Heritage Programme.
8. The oil storage tunnels under Darwin provide a unique and exciting opportunity for a self-guiding display commemorating the bombing and destruction of Darwin in February 1942. Proposals by the Department of Transport and Works at Attachment B will enhance State Square as the focal point of Darwin City.

OPTIONS

9. There are three options for Cabinet consideration:
 - (a) approve funding for the WWII Heritage Sites and Trails Programme as recommended at Attachment A;
 - (b) defer the proposal in favour of other projects;
 - (c) approve a lesser programme.

Deferral, Option (b) is not recommended. It will mean that interpretation and site preparation will not be completed for the expected influx of ex-servicemen and women and other visitors to the Northern Territory in 1992.

Option (c) is not recommended. The Northern Territory's 1992 WWII Commemorative programme will be severely restricted to a low key event.

Option (a) is the preferred option. It ensures that the required impetus is given to the presentation and protection of significant WWII sites for public enjoyment in the 1992 WWII Commemorative year and beyond.

PUBLIC IMPACT OF THE RECOMMENDATIONS

10. Although ex-servicemen and women strongly condemn any suggestion of commercialisation of the WWII commemorative year, they are not adverse to the Government's genuine effort to sensitively preserve WWII sites in the public interest.
11. The recommendations affecting WWII sites in this submission are primarily aimed at investing funds through local communities which will improve many sites in rural areas along the Stuart Highway. The National Trust, landowners, Aboriginal groups, tourist promotion associations, community government councils, progress associations have all indicated a willingness to co-operate in reviving interest in the sites, repairing

them and promoting public education. Whilst the programme is initially aimed at the 1992 commemorative year, it can be anticipated that the interest generated will provide stimulus for continuing visitor interest in the military heritage of the Territory.

FINANCIAL CONSIDERATIONS

12. Detailed financial considerations are at Attachment A. \$350,000 would be sought as additional funding by the Conservation Commission, Museums and Art Galleries Board and Department of Chief Minister in 1991/92 with the remaining funding absorbed within existing programmes by re-assignment of priorities. However, National Estate Grants Programme funding for 1991/92 will not be approved and provided by the Commonwealth before March 1992. NT appropriation of \$80,000 will be required in anticipation of Commonwealth approval and reimbursement. \$400,000 programme substitution will be required as a priority Capital Works item on the Transport and Works Capital Works Programme with a further \$140,000 proposed for 92/93.

REGULATORY IMPACT

13. The proposed work does not have any regulatory impacts.

EMPLOYMENT AND INDUSTRIAL RELATIONS

14. Employment is provided through local government and progress associations. No additional staff are required. The Conservation Commission has funded and staffed an interpretive officer to work with the Museums and Art Galleries Board for 12 months, within



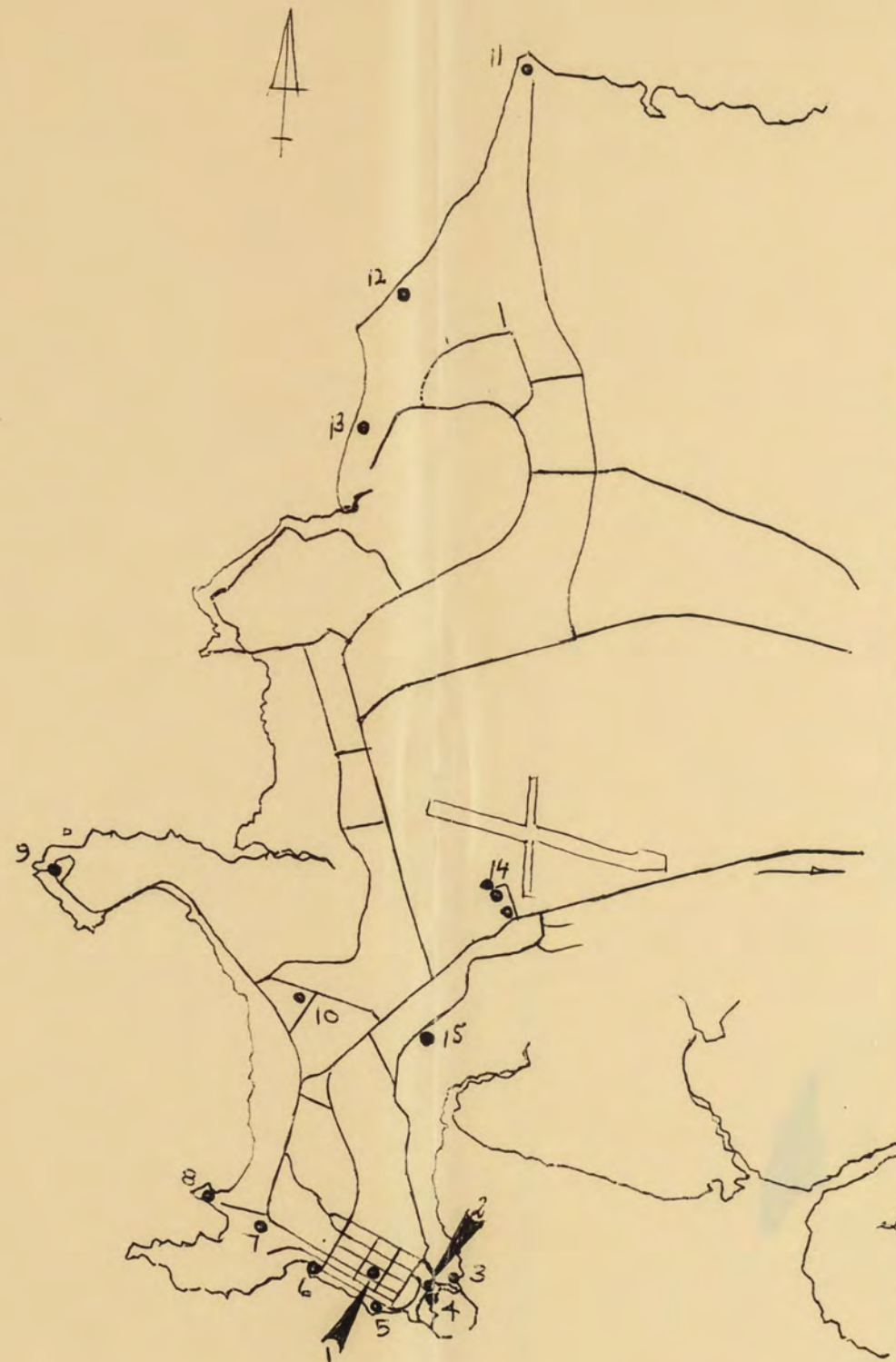

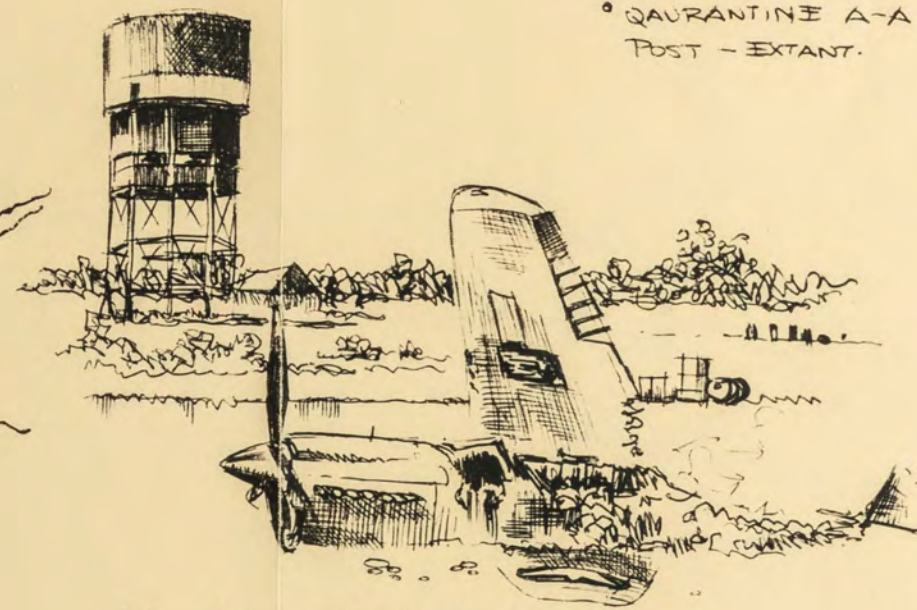
