1. THE ISSUE

To carry out a Youth Needs Survey in the Northern Territory as proposed by Australian Frontier Incorporated, in conjunction with the Department of Youth, Sport and Recreation and voluntary organisations.

2. BACKGROUND

The Northern Territory Government is committed to provide a Youth Programme throughout the Northern Territory. In support of this commitment the Government recently established the Office of Youth, Sport and Recreation.

A recent Cabinet decision approved the establishment of a Northern Territory Youth Advisory Council. Government programmes can best be developed with accurate knowledge of youth needs. No surveys have been conducted on youth needs on a Territory wide basis. National youth surveys have been useful in relation to the general principles of youth needs, but the information is not specific enough to provide for a state-wide programme.

3. CONSIDERATION OF THE ISSUES

Propose to engage a firm of consultants to conduct survey to provide information and assist in establishing a communication network. (refer Attachment B).

4. BENEFIT TO THE NORTHERN TERRITORY GOVERNMENT

The information obtained through this method will -

- 4.1 Enable the Northern Territory Government to develop and implement appropriate programmes to meet the needs identified and to involve all relevant government and voluntary agencies in these programmes.
- 4.2 Enable the Northern Territory Government to take immediate action in some areas to alleviate some of the more urgent needs.

- 4.3 Enable the Northern Territory Government to evaluate Federal Government programmes in so far as they affect young people in the Northern Territory in particular those designed to assist the young unemployed.
- 4.4 Provide an opportunity to further define the future role of local Government Authorities in the provision of services to young people.
- 4.5 Provide a data base and a framework for this long term, continuous development and evaluation of policy.

A YOUTH NEEDS SURVEY FOR THE NORTHERN TERRITORY

Cabinet has approved the undertaking of a major survey into the needs of young people in the Northern Territory, The Minister for Youth, Sport and Recreation, and the Acting Minister for Community Development, Nick Dondas, announced the move today.

He said the information obtained will enable the Government to develop and implement appropriate programmes to meet the needs of young people identified through the survey.

Mr Dondas said he was very pleased that the range of approaches to be taken in the survey, meant that many people across the Territory will be asked for comment. He explained that young people in the five main Regional Centres of Alice Springs, Tennant Creek, Katherine, Darwin and Nhulunbuy will be encouraged in one day workshops to identify the issues that concern them.

Concurrently, he said, people involved with young people such as Youth Organisations, teachers, parents, will be asked for their views of young peoples needs. Questionnaires will also be sent to High Schools. The survey will also invite any member of the community to make submissions to the survey team.

Mr Dondas in outlining the approach to Aboriginal communities said that the Government is keen to co-operate with the existing contacts and channels in the communities. In this way, he was delighted to announce that the Y.M.C.A. had offered its full support to this Government initiative of a Youth Needs Survey, by making available the Y.M.C.A. Officers in Papunya, Warrabri, Yuendumu, Amoongona, Hooker Creek, Melville Island, Elcho Island, Maningrida, Darwin area, Milingimbi, to assist with the survey.

These workers will over a period of six weeks, through individual and group discussion encourage the Aboriginal youth to identify their needs and concerns.

Nick Dondas also explained that the final report due in November will enable the Government to evaluate Federal Government programmes in so far as they affect young people in the Northern Territory in particular those designed to assist young unemployed.

The survey will be conducted over a seven (7) month period with two Interim Reports available to Ministers on progress.

A. SURVEY CONTENT

The essential requirements of a Youth Needs Survey are:-

- (i) the collation of available data.
- (ii) in-depth consultation with young people themselves and with service providers.
- (iii) an evaluation of the information obtained to provide options for action to be taken to meet the youth needs identified.
- (iv) establishment of communication channels with young people and relevant groups to maintain a continuous formulation of policy and implementation of appropriate programmes.

B. TIMING.

The programme as proposed extends over seven (7) months. This is essential for an effective survey of this type.

However, two (2) Interim Reports will be provided to enable urgent action to be considered and to enable the Northern Territory Government to keep the community informed.

C. METHODS

The Australian Frontier Survey Design proposes to meet these aims in the following way:-

1. Australian Frontier will collate data available from the Bureau of Statistics, the Northern Territory Inquiry into Social Welfare and relevant agencies in other states and at Federal level.

The Office of Youth, Sport and Recreation will assist in obtaining relevant data from other Northern Territory Government Departments.

- Community consultation will involve two (2) concurrent programmes -
 - (i) Public forums in Darwin, Alice Springs, Tennant Creek, Katherine, Nhulunbuy.

These are intended to be full day seminars with participants drawn from young people, government agencies, providers of various professional services to youth.

Australian Frontier will initiate steering committees in each of the five (5) towns.

The consultants will provide agendas, questionnaires, instruction and score sheets and will be responsible for the running of each meeting.

(ii) Interview programmes in thirteen (13) Aboriginal Communities; Papunya, Warabri, Yuendumu, Armoongana, Hooker Creek, Melville Island, Bathurst Island, Elcho Island, Maningrida, Milingimbi, Darwin area, Yirrkala, Groote Eylandt and Roper River.

Australian Frontier will visit each community and assist appropriate workers in these communities to devise a programme of individual and group discussions.

Workers over a period of approximately six (6) weeks will collect individual or group responses from young people in the communities.

The consultants will provide assistance and advice as required and will return to each community to collect the interview results. An average of two (2) days per visit per community have been allowed. It is recognised that there are certain limitations to this method because of the difficulties in collecting information in such a short period of time (six weeks) and limited visits by the consultants (minimum of two visits are planned).

3. The consultants will provide questionnaires to all high schools including colleges for Aboriginal students.

The consultants will provide a general questionnaire to facilitate the preparation of submissions by members of the public and publicise its availability and readiness to receive such submissions.

4. Evaluation and Review of Data

The consultants will review and summarise data collected and evaluate needs expressed against services available in the Northern Territory and in other States.

Australian Frontier will provide a final report containing data obtained, a description of the process and a series of options for action to meet the needs identified as well as recommendations for further research or consultations required.
